2. First order must be \$500.00 Retail value which is \$300.00 after discount.
(\$500.00 less 40% = \$300.00 order)
Or if you are going to spend \$500 net (after discount) we will give you 60% off.
3. First order is C.O.D. Or credit card – we accept Visa, MC, Discover or AM.EX
4. Shipping is free on net orders over \$500 to US customers, on orders under \$500 you pay the actual cost of shipping. International customers pay all shipping costs.
5. To restock, the minimum order is \$150.00 net (after discount) but this is not to be done on each order.
6. On all subsequent orders after your first order, you have 30 days for payment, or you can opt to continue with the C.O.D. Or credit card payments.
7. Payment must be made within the 30 days after the shipping date or there is a late fee charge of \$10.00 with the possibility of next orders having to be placed C.O.D.
